A Message from Board President Jere Green

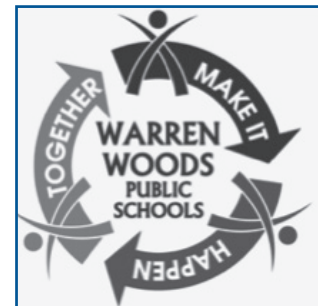
AS THE STATE CONTINUES to introduce legislation that is supposed to “reform” schools, I ask you to consider the following perspective.

During my tenure as a member of the Board of Education in Warren Woods Public Schools, I have had the opportunity to visit schools and extra-curricular activities and I am here to report that there is absolutely nothing wrong with our schools, despite the consistent rhetoric about the failure of public schools.

MY TIME ON THE BOARD has confirmed for me that those in control of education policy must stop changing what is expected of schools from year to year in order to hold them accountable. The rate at which policymakers introduce new forms of assessments, ways to make Adequate Yearly Progress, Persistently Low Achieving School lists, which are now Priority, Focus, and Reward Schools, etc. will do nothing in the long run to help Michigan recover economically and prosper once again.

These kinds of policy “rabbit holes” simply distract teachers, parents, and administrators from focusing on their true mission of nurturing and teaching children how to work and live in our society. Consider this the next time your child must participate in a state-mandated test or assessment, which the schools are required to give in order to get money to operate.

NOTED SUPREME COURT JUSTICE Louis Brandeis once stated that “You can have great wealth concentrated in the hands of a few or you can have a democracy, but you cannot have both.” It is time to put the power and control of public education back into the hands of parents and local school districts where it belongs and let them hold schools accountable for their own children. And at the same time, honor the work of teachers and staff who educate our children.

Wireless Network installed at Warren Woods-Tower High School

Thanks to a generous donation of \$12,000 from the Warren Woods-Tower Booster Club, a \$10,000 grant from the Warren Woods Education Foundation and a donation of \$4,915 from the WWT Student Council, a wireless network was installed this fall at Warren Woods-Tower High School.

Students using district laptops and netbooks can now move throughout the building during the day and stay connected to the internet. Students will also be able to connect to the internet using their cell phones or other devices in the Media Center, Commons and Cafeteria throughout the day. After school hours, the wireless network will be available throughout the building for all students and visitors.

According to Building Principal Mike Mackenzie, “It’s great that we no longer have to be restricted to just computer labs in order to provide our students with an opportunity to learn on line.”

The Board of Education and Administration would like to once again thank the Warren Woods-Tower Booster Club, Warren Woods Education Foundation and the WWT Student Council for partnering together to provide the funding for the project.

Thanks to the combined support of the POHI Parents Club and the WWT Booster Club, the Special Education Department was able to purchase a CNC router for the workshop to create awards and plaques for departments throughout the district. Logos and text are imported from a laptop and transferred to a computer controlled router that engraves onto wood. Salvaged boards from demolished bleachers in the administration building have been used to prepare plaques for the Drama Club, NHS, and the Athletic Department. Most recently, students created custom nameplates for members of the Warren Woods Board of Education.

In addition to the projects using the router, students also make hand-turned pens using lathes that were discovered in the district by our supervisor, Dan Simeck. Our director, Justin Michalak supported the replacement of palm sanders to involve more students in the finishing process. It has truly been a group effort developing a 21st century woodshop that addresses both academic and transition goals of our students. Working with wood has given students in special education a unique opportunity to apply classroom concepts and develop pre-vocational skills while creating valuable products the staff and students can treasure for a lifetime. We hope to expand the program in the future.

GRIEVANCE PROCEDURES

**FOR TITLE VI OF THE CIVIL RIGHTS ACT OF 1964
TITLE IX OF THE EDUCATION AMENDMENT ACT OF 1972
SECTION 504 OF THE REHABILITATION ACT OF 1973
AGE DISCRIMINATION ACT OF 1975
TITLE II OF THE AMERICANS WITH DISABILITIES ACT OF 1990**

Section I

Any person believing that the Warren Woods School District or any part of the school organization has inadequately applied the principles and/or regulations of (1) Title VI of the Civil Rights Act of 1964, (2) Title IX of the Education Amendment Act of 1972, (3) Section 504 of the Rehabilitation Act of 1973 (4) the Age Discrimination Act of 1975, and/or (5) Title II of the Americans with Disabilities Act of 1990, may bring forward a complaint, which shall be referred to as a grievance to;

Section II

The person who believe a valid basis for grievance exists shall discuss the grievance informally and on a verbal basis with the Civil Rights Coordinator, who shall in turn investigate the complaint and reply with an answer within (5) business days.

If the complainant feels the grievance is not satisfactorily resolved, they may initiate formal procedures according to the following steps.

Step 1

A written statement of the grievance signed by the complainant shall be submitted to the local Civil Rights Coordinator within five (5) business days of receipt of answers to the informal complaint. The Coordinator shall further investigate the matters of grievance and reply in writing to the complainant within five (5) business days.

Step 2

A complainant wishing to appeal the decision of the local Civil Rights Coordinator may submit a signed statement of appeal to the Superintendent of Schools within five (5) business days after receipt of the Coordinator's response. The Superintendent shall meet with all parties involved, formulate a conclusion, and respond in writing to the complainant within ten (10) business days of the meeting.

Step 3

If unsatisfied, the complainant may appeal through a signed, written statement to the Board of Education within five (5) business days of receiving the Superintendent's response in Step 2. In an attempt to resolve the grievance, the Board of Education shall meet with the concerned parties and their representative within forty (40) days of the receipt of such an appeal. A copy of the Board's disposition of the appeal shall be sent to each concerned party within ten (10) days of this meeting. The decision of the Board of Education is final.

Student Directory Information

Each year the district will provide public notice to students and their parents of its intent to make available, upon request, certain information known as "directory information". The Board designated, as student directory information, a student's name, photograph, date and place of birth, major field of study, participation in officially recognized activities and sports, height and weight, if a member of an athletic team, dates of attendance, date of graduation, awards received, or any other information which would not generally be considered harmful or an invasion of privacy, if disclosed.

Parents and adult students may refuse to allow the district to disclose any or all of such directory information upon written notification to the district within ten (10) days after receipt of the district's public notice. A form for this purpose is available at each building or at the pupil accounting office.

The district may disclose directory information on former students without student or parental consent.

The superintendent shall prepare procedures to ensure that students and parents are adequately informed each year regarding their rights to inspect and review the student's education records.

The principal of each building or the department is charged with the responsibility of maintaining and safeguarding the educational records. Employees of WWPS in the areas of instruction, special services, administration, research / evaluation and student records are authorized to have access to records in the educational interest of the student.

This would include the student's academic, physical, emotional, personal, social and vocational decisions. Any other person except those agencies specified in the Act must have a signed consent of the parent or eligible student to gain access to the educational records and request amendments prior to their being released.

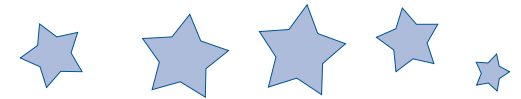
