Dear EHS Families,

Enclosed with this letter is your student's 3rd Quarter Progress Report. We hope that you find the grades satisfactory. If not, please note that we have two additional interventions to help them find academic success at EHS.

First, starting today, we will have lunch recovery for any student who receives a 64% or below in any academic class. For lunch recovery, students eat in the classroom of a teacher, instead of the cafeteria. During this time, students are able to complete missing work to raise their grade. Once their grade is above 64%, they exit lunch recovery and return to the cafeteria during their lunch period.

Second, we have tutoring every Tuesday and Thursday, after school from 2:30-3:30 at EHS. Mrs. Krzesiak is a former EHS teacher who specializes in math, but is able to help the students in other subject areas as well. If your student is not missing any assignments, they are able to stay after on those days to work on e2020.

We are excited to announce that we have changed the start time of our upcoming parent-teacher conferences, to accommodate you as much as possible. We understand that it is not always easy to come back in the evening after a long day. Our next conference is Thursday, March 10^{th} . Our new start time, which we hope will help with attendance, is 2:45 pm - 5:45 pm.

We continue to offer Power Parent, which allows families computer access to their student's academic progress daily. We encourage <u>all</u> parents/guardians to sign up. Together, we can work to assure your student's academic success. If you are interested in signing up, Mrs. Maljak will be in the front office during conferences. You can also stop by during regular school hours.
